

Subject: Tender/Quotation for Food Catering and Lodging Arrangements

1. Sealed Tender/Quotation for the supply of the articles shown in the **attached format** are invited by the undersigned on behalf of Kendriya Vidyalaya, Kathua (J&K) from 28.07.2022 to 08.08.2022 by 01:30 p.m.. Tenders should be sent under strong sealed cover marked as a "**Tender/Quotation for Food Catering and Lodging Arrangements**" in the Vidyalaya. The tenders/quotations will be opened in the office of the undersigned at 02:00 P.M. on 09.08.2022.
2. The tender/quotation shall be submitted according to the terms & conditions specified in paragraphs 3 to 23. Unless specified otherwise in the quotation it shall be construed that the terms & conditions stipulated hereunder have been agreed to by the bidder. If any case the bidder violates the terms and conditions, the Tender will be rejected.
3. The Contractor will have make arrangement for cleanliness of Kitchen Area and it surroundings to the satisfaction of the KV. The contractor shall also be responsible for the safe and hygienic disposal of the waste material.
4. The contractor shall arrange for crockery, utensils, boilers, juice, cooking gas cylinders, cooking store etc. and items of similar nature of goods quality as approved by Kendriya Vidyalaya Kathua/KVS at his own cost and maintain the said items in proper and hygienic conditions for due discharge of obligations in respect of running of meets.
5. The contractor will have to provide employees in proper uniform for service.
6. The contractor will be required to provide service in the premises of Kendriya Vidyalaya Kathua.
7. The contractor shall placed such persons as are declared medically fit, pay minimum wages. No employee will be under the age of 18 years.
8. Only cooking gas is to be used in the in the preparing of hot drinks & cooking which is to be arranged by the contractor including gas cylinders.
9. The contractor will be fully responsible for the repair/maintenance, cleanliness, breakage and damage done to the building and sanitary, electrical and any other fitting and fixtures installed in Kendriya Vidyalaya premises provided to him for the purpose. Furniture provided to the contractor will be maintained properly. Any loss/damage (including repairs) to the same will have to be made good by the contractor at his cost.
10. Material is used for cooking purpose tea, coffee, spices, vegetable, meat/chicken, fish, eggs etc. should be of good quality.
11. The contractor will take all necessary precautions against fire hazards and comply with rules and regulations as laid down by concerned local authorities and to the satisfaction of Kendriya Vidyalaya Kathua/KVS.
12. The menu as approved by Kendriya Vidyalaya Kathua should be displayed conspicuously daily.
13. The Kendriya Vidyalaya Kathua shall not be in any manner be treated as the employer of the workers or concerned with the terms of their employment or conditions of their services since the relationship of employer and employees shall always be considered to be between the bidder / contractor will make these conditions clear to them categorically and in writing, and their acceptance of these terms shall be communicated to KV also.
14. Under no circumstances any of the contractor's employee will stays in the Kendriya Vidyalaya Kathua premises beyond working hours. He will ensure that the kitchen rooms are properly locked and secured during closed hours of KV. The access to the space allotted to the contractor will be as per the conditions and in the mode as prescribed and regulated by the KV from time to time which will be binding on him and his employees. The KV reserves the right to inspect the premises allotted to the contractor including the store at any time.
15. The contractor shall not entertain any orders, or supply from outside KV.
16. The contract will be for two years to start with from the date of signing the agreement and agreement may be renewed by the KV on such terms and conditions as may mutually be agree upon between the parties, if the KV is not satisfied with the working of said contractor. The contractor, if so desires, may seek termination of the contract by giving written notice of not less than three months duration the agreement period.

17. The contractor will, at all times, ensure discipline, descent and courteous behaviour by his employees while they remain in premises of KV. In case any of his employees indulges in any act of indiscipline, misbehavior of slogan shouting or indulges in violent act(s) or abets others in doing so and it is prima facie proved, the contractor shall remove the employee concerned from the premises immediately or receipt of written communication from the authorities which will be duly acknowledged by the contractor.
18. Under exceptional circumstances the Kendriya Vidyalaya Kathua/KVS reserves the right to change any term and condition as and when warranted.
19. In case of any dispute arising out of the interpretation of the terms and conditions of the contract, the decision of Kendriya Vidyalaya Kathua / KVS will be final and binding.
20. The Bidder shall deposit **Rs.1000/- (Rupees One Thousand only)** in the form of Bank Cheque/DD valid for 90 days after the date of submission of bids or DD/Bank Cheque drawn in favour of **Vidyalaya Vikas Nidhi, K.V. Kathua (J&K)** payable at **Kathua** as Earnest money along the bid/quotation. The Earnest Money shall be returned to the unsuccessful bidders after the award of the contract.
21. The contractor will have to deposit **Rs.10,000/- (Rupees Ten Thousand Only) or 5% to 10%** as Performance Security in the form of DD/ CDR, drawn in favour of Principal, Kendriya Vidyalaya Kathua (J&K). The same will be refunded without interest when the contract is over and premises are headed over the KV and all dues from the contractor have been settled.
22. The contract whom the above terms and conditions are acceptable shall submit the completed tender forms to this Office by stipulated date and time in sealed cover.
23. The contractor will not further sub-contract the contract to any other party. In case the contractor is found having sub-contracted this contract, the contract will be terminated without any notice.
